



Party Agreement

In accepting this agreement, you acknowledge the following:

- 1. Event Time:** You will have the private party room for one (1) hour and forty-five (45) minutes. Other parties may precede or follow yours, therefore, if the party goes over the allotted time, the client will be charged an additional fee of \$20.00 per each 5 minute time frame over allotted time.
- 2. Payment:** A deposit of 50% of total party price must be made at time of reservation in order to secure your date and time. Final payment is due at the end of your party time.
- 3. Cancellations:** A full refund will be issued on cancellations made 14 days prior to your party date. Parties cancelled within 13 days or less to your party date will not be issued a refund.
- 4. Start Time:** The start time of your party will be the time for the guests to arrive and they will be directed to the private party room.
- 5. Setup/Cleanup Time:** You will be able to arrive 5 minutes before your party for setup of the room. The HANG Host will begin cleanup of the room 15 prior to the end of your allotted party time.
- 6. Gifts:** Due to safety concerns, we require that all gifts remain unopened during the party.
- 7. Decor:** You are welcomed to bring balloons and any other decoration to party room. Glitter, confetti, piñata, and silly string are **not permitted**. Nails, staples, glue, tape, or any like materials are not allowed on any wall, window, or doors. Decorations may be pinned to cork boards throughout party room walls.
- 8. Food and Drink:** All children counted toward party package will receive a small water. You may bring outside food and drink. You may also bring crockpots and coolers (we do not provide ice). Coolers must not leak. No skillets or small grills allowed. Food deliveries should arrive within 30 minutes after your setup time. If food arrives late, the party time will not be able to adjust accordingly. Party package includes paper plates, plastic utensils, and paper napkins. Cups are not provided. **No Food or Drink is permitted in play area.**

- 9. Lost or Damaged Personal Property:** HANG assumes no responsibility for the damage, theft, or loss of any articles left at HANG property prior to, during, or following the event by any guests of the private party. The client and guardian will be responsible for any damages to HANG property by any participant attending their private party and will be charged for all/any damages to the credit card on file for the event.
- 10. Play Rules:** All play participants deserve respect and the opportunity to enjoy a fun and safe environment. Children must be supervised AT ALL TIMES by their guardian. If a child's guardian leaves the premises, then the client reserving the party room becomes responsible for the child. Rough play, physical aggression, verbal aggression, destruction of play area or any other property will not be permitted and the participant and guardian may be asked to leave. All participants must wear socks in the play area. Socks will be available for purchase at front desk.
- 11. Guests:** To ensure accuracy with your party guest list, we encourage you to provide us with a guest list and you to verify accuracy before your final payment at the registers. Once final payment has been made, this indicates that you are in agreement with the total number of guests indicated in Party List.
- 12. Waiver:** It is the host family's responsibility to obtaining signed waivers from all participants (signed by participants guardian only) prior to participation in party. Paper waivers will be available at front desk as well. Any child without a signed waiver by guardian will not be allowed to participate.
